Climate Education in Judicial Systems:

In the past few years, a surge in social demand relating to the prevention and remediation of climate change impacts, has been experienced both in the region and globally. In turn, this has resulted in a call to strengthen the role of institutions and justice systems to implement the Paris Agreement along with related legal instruments and compliance of State obligations. In this context, IIJS offers the following services and products designed for **stakeholders in judicial systems:**

- Identifying common baselines and good, replicable practices for institutional strengthening which contribute to the advancement and implementation of NDCs in a country or region.
- Prioritizing and mapping institutional needs and policies in the area of climate change at the local and national levels.
- Fostering dialogue on parliamentary support on legal standards and their compliance.
- Dialogue and building capacity of lead negotiators and key sector stakeholders with regards to the Paris Agreement implementation and NDCs to analyze priorities, solutions and good practices.
- Expert assistance to sectoral authorities connected to implementing climate change pledges to discuss experiences and mechanisms in the cross cutting and inter-sectoral link of the climate change agenda.

- Identifying good practices with potential replicability across sectors.
- Identifying international standards and certifications in the field of sustainability which allow for value added production and greater profit From niche markets.
- Identifying enabling conditions for greater productivity, sustainability, and a reduced carbon footprint.
- Monitoring the compliance of international standards in responsible supply chains for minerals and other commodities.
- Advise on productivity shifts of emerging products in shifting or surging market demand.
- Advise for trade associations and private sector for the revitalization of exports in key sectors through traceability and sustainability.

- Exchanging experiences and generating jurisprudential dialogue surrounding good practices in the implementation of legislation, to contribute to the success of the Paris Agreement's objectives.
- Development of principles of climate justice that contribute solutions through analysis and exchange of good legal and judicial practices for the implementation and effective functioning of the Paris Agreement, in coherence with the obligations of States in other related legal instruments.
- Specialty training in climate justice, with a focus on the role of science, as well as the socioeconomic factors that connect law to climate change. In particular, the aim is to address aspects such as uncertainty, asymmetry in impacts, public health, human rights, and applicable principles.
