HOW WE DO IT?

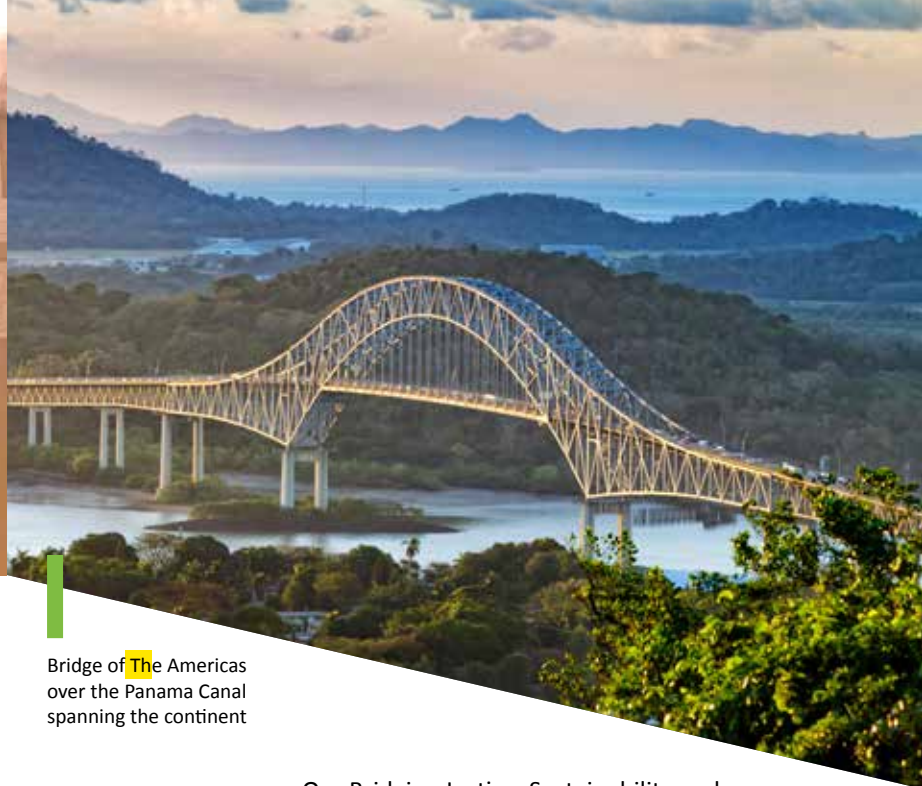

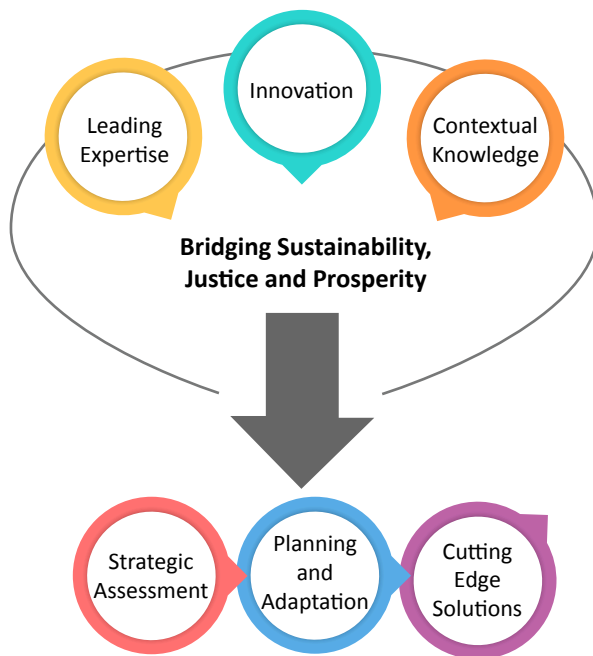
WHY WE DO IT?
